Fireside Chat with Howard Marks

While taking several attendee questions, the pair discussed the importance of active management and taking a long-term approach to investing. Consistent with Capital Group's commitment to offering choice to investors, Mike shared the firm's philosophy behind designing both fully active and hybrid active/passive target date solutions.

Evaluating OCIO Providers – Getting the Full Picture for Assessment of OCIO
