CIEBA Public Policy Washington Update

Dennis Simmons of CIEBA and Michael Kreps of Groom Law Group updated Members on practical aspects of the SECURE Act and other public policy issues affecting CIEBA's fiduciary Members, including three active Supreme Court ERISA cases.

Rounding out the agenda were very informative CIEBA DC and DB Committee sessions, and our CIEBA Meeting Onsite Survey session:

The CIEBA DB Committee presented a panel hosted by CIEBA Members Jay Laramie of PepsiCo and Rob Sparling of Dow, with panelists Michael Moran of Goldman Sachs and Brigen Winters of Groom Law Group providing thoughts on how CIOs can effectively consider the upcoming DB plan funding law changes and the potential funding crisis that those changes may precipitate.

The CIEBA DC Committee presented both: (i) JP Morgan's Anne Lester, who shared her views on developments with DC post-retirement solutions, and (ii) CIEBA Member, Johnson & Johnson's Anna McTigue, who led a helpful discussion on lessons learned with J&J's recent move to custom target date funds.

The CIEBA Onsite Survey was facilitated by former IBM CIO, Jay Vivian, who walked attendees through a practical, real-time analysis of survey information inputted by attending Members, providing timely and actionable take-aways on asset levels, returns and plan funding data.

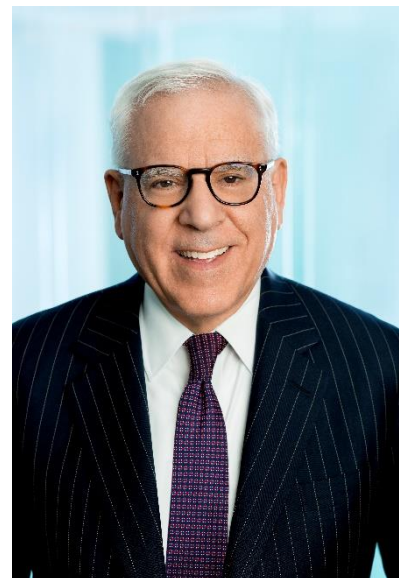
March 2020: CIEBA Holds First Virtual Working Group Meeting

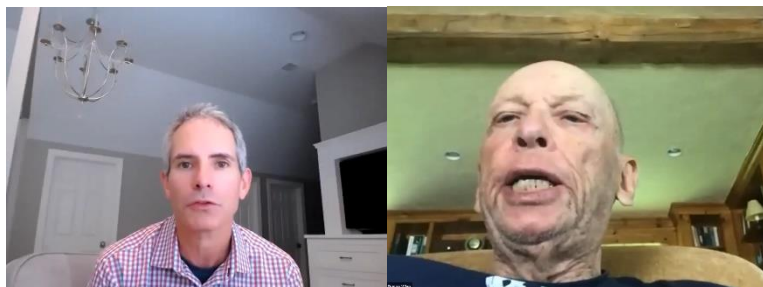

Investment Discussion with Byron Wien & Joe Zidle of Blackstone

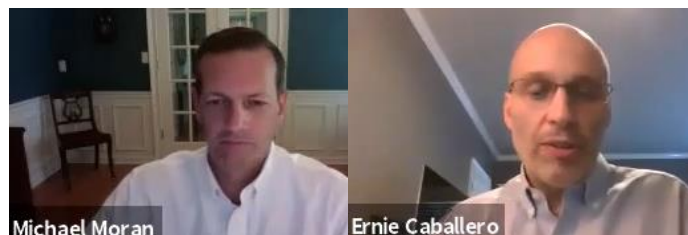

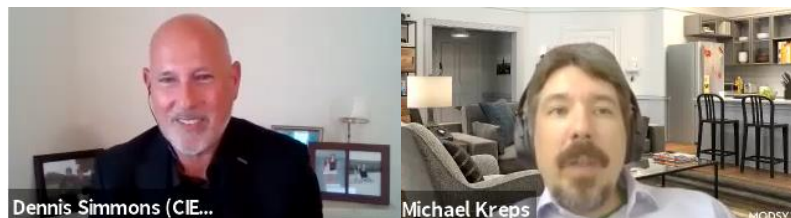

Rounding out the agenda were highly informative CIEBA DC and DB Committee sessions:

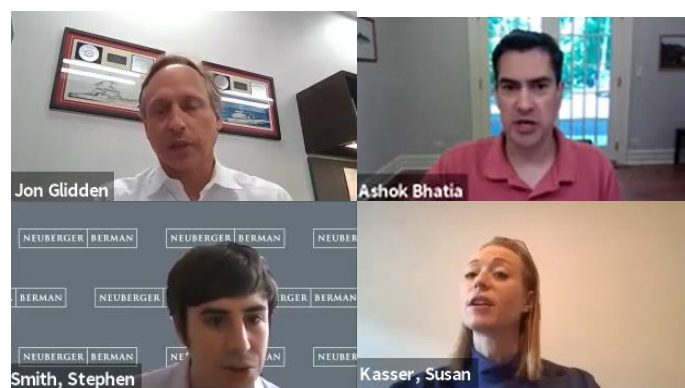

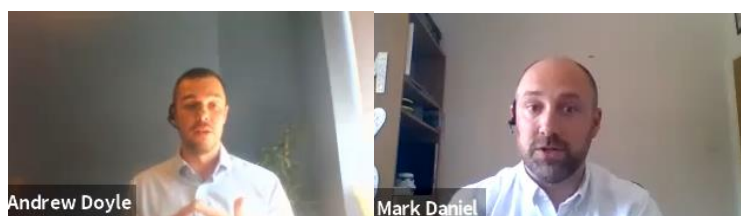

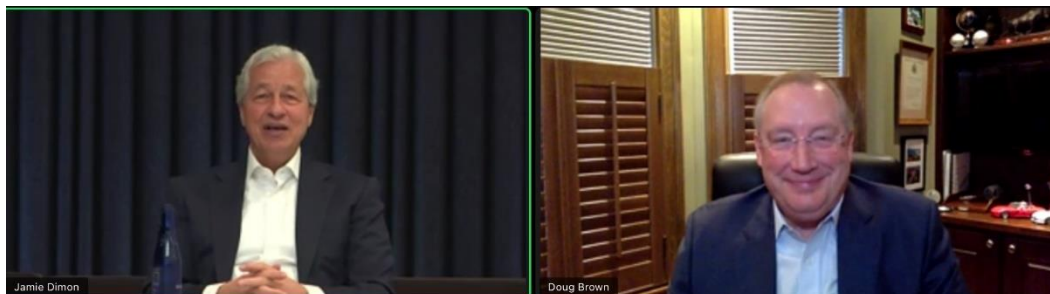


UK Pensions: Changes, Implications and Actions

2020 U.S. Elections and the Public Policy Landscape: Preview & Implications

Ken Mehlman, Partner, Global Head of Public Affairs & Co-Head Global Impact, KKR and former Chair of the Republican National Committee and **Rob Sparling**, CIO, Dow Inc. began the day on Tuesday morning by discussing the macro implications of the 2020 U.S. election on the investment landscape. Ken fielded questions from the audience on the huge impact social media is having on how campaigns are run and on how leaders can use social media to unite people.

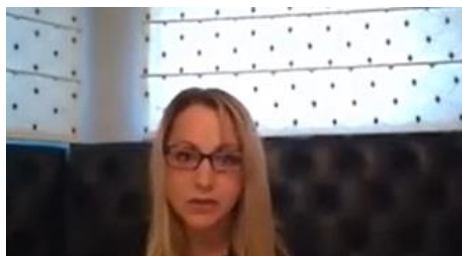

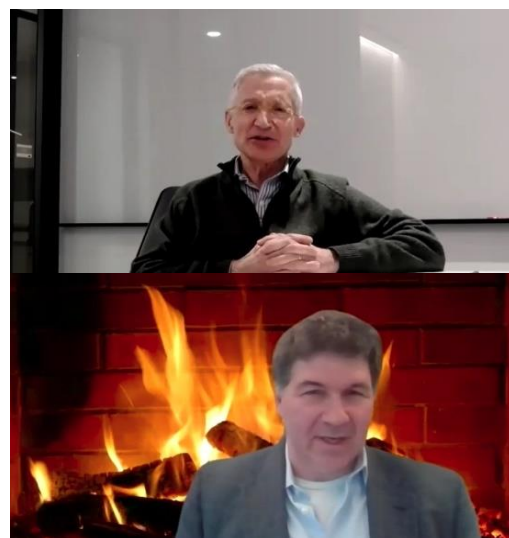
2021 Outlook with Henry McVey: “Another Voice”

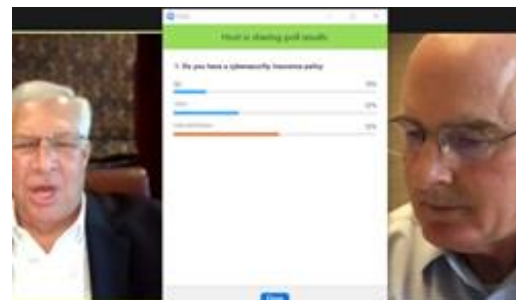

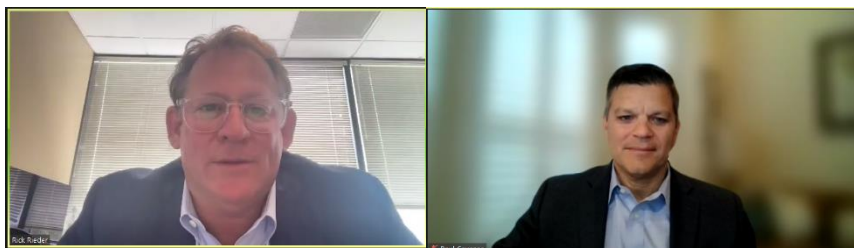
Mike Moran's “First Take”

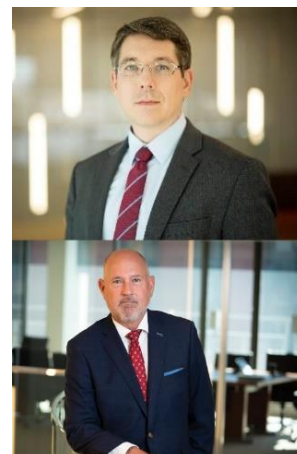
CIEBA On-Site Survey Results

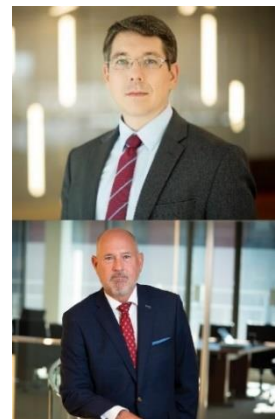

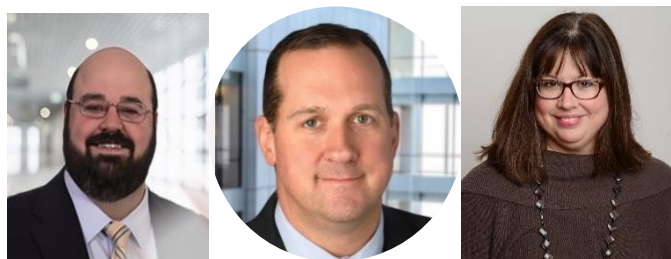
